

22579VIC Course in Verifying the Correct Use of Adrenaline Injector Devices

Overview

This course teaches the skills and knowledge required to be able to verify that individuals who have undertaken the ASCIA Anaphylaxis e-training for Victorian Schools can demonstrate correct use of required adrenaline injector devices. This includes preparing for the verification activity, conducting the verification activity with reference to the required checklist, and completing workplace documentation.

This unit of competency contributes towards meeting the requirements of *Ministerial Order No 706: Anaphylaxis Management in Victorian Schools*. The role of the verifier is part of the role of school anaphylaxis supervisor; but is a function that may also be performed by other school staff who have met the training requirements.

The skills and knowledge described in this unit is only relevant to the Victorian school environment. It applies to Victorian school staff who have responsibility for conducting verification activities and performing the function of a trained verifier. Trained verifiers observe Victorian school staff who have undertaken the *ASCIA Anaphylaxis e-training for Victorian Schools* and verify that they can demonstrate correct use of all adrenaline injector devices currently approved for use and available in Australia, as identified in the ASCIA anaphylaxis e-training.

Key Learning Outcomes

- Need for urgent administration of adrenaline in the onset of anaphylaxis
- Current ASCIA Action Plan for Anaphylaxis (General)
- Cultural sensitivity and equity considerations
- Components and functions of all adrenaline injectors currently available on the Australian market, as identified in the ASCIA Anaphylaxis eTraining for Victorian Schools
- Checks required on adrenaline injectors to confirm their suitability for use
- Correct positioning of casualty prior to the use of an adrenaline injector
- Appropriate positioning of the person administering the adrenaline injector, in relation to the casualty
- Correct placement and activation of the adrenaline injectors
- Summoning medical assistance in accordance with the ASCIA Action Plan for Anaphylaxis (General)
- Correct procedures for used adrenaline injectors
- Verification activity recording and reporting requirements
- Requirements for refresher training to maintain currency of competence for self and candidates

Unit of Competency

On successful completion of this course, students will be eligible for a Statement of Attainment (SOA) for:

Including Unit:

- VU23086 Verify the correct use of adrenaline injector devices

Pre-Requisites

Entrants to the 22579VIC *Course in Verifying the Correct Use of Adrenaline Injector Devices* must:

- Have undertaken the current version of the *ASCIA Anaphylaxis e-training for Victorian Schools*:
 - within last 30 days, and
 - can evidence successful completion of this e-training with an *ASCIA e-training certificate* (signed in accordance with current Victorian School Anaphylaxis Guidelines).

AND

- Hold a Statement of Attainment for either of the following courses which have been completed within the timeframe specified in current Victorian School Anaphylaxis Guidelines:
 - 22300VIC/22578VIC Course in First Aid Management of Anaphylaxis (*or equivalent re-accredited version of this course*)

OR

10710NAT Course in Allergy and Anaphylaxis Awareness (*or equivalent previous or re-accredited version of this course*)

Course Requirements

Foundation skills are the underpinning communication skills required for participation in the workplace, the community and in adult education and training.

Learning – to learn to verify correct use of adrenaline injectors

Reading – in order to read and interpret information, device labels and checklists

Writing – to prepare required documentation and record verification activity in required format

Oral communication – to provide feedback on correct use of adrenaline injectors and use appropriate verbal and non-verbal language to promote a supportive verification environment

All training and assessment materials and equipment will be supplied throughout the course. Students will need to bring a blue or black pen and wear comfortable, casual clothing.

If you are concerned about any of these requirements please contact your training provider prior to enrolling into the course.
